Payments covering contributions to the Cement Masons' Trust Fund, Pension Fund, Vacation Fun, Annuity Fund, Apprenticeship Fund, I.A.P. Where an employee is laid off and receives his wages other than on the employer's regular pay day, said employee shall be given a check to cover the contributions due the aforesaid Funds.

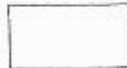

To Whom It May Concern:

Effective July 1, 2012, the United Cement Masons' Union Local 780, under the option exercised by the collective bargaining agreement, requires that all participating employers make contributions per hour paid for work performed by covered employees on or after July 1, 2012 until June 30, 2013.
